SPECIAL CONTRACT TERMS AND CONDITIONS

CONTRACT SCOPE/OVERVIEW: This Contract No. 7220-05 (identified here and in the other documents as the "Contract") will cover the requirements of Commonwealth agencies for Carpet and Installation.

<u>ORDER OF PRECEDENCE:</u> These Special Contract Terms and Conditions supplement the Standard Contract Terms and Conditions For Statewide Contracts for Supplies. To the extent that these Special Contract Terms and Conditions conflict with the Standard Contract Terms and Conditions For Statewide Contracts for Supplies, these Special Contract Terms and Conditions shall prevail.

TERM OF CONTRACT: The Contract shall commence on the Effective Date, which shall be no earlier than July 1, 2003 and expire on June 30, 2004.

OPTION TO EXTEND: The Department of General Services reserves the right, upon notice to the Contractor, to extend the Contract or any part of the Contract for up to three (3) months upon the same terms and conditions. This will be utilized to prevent a lapse in Contract coverage and only for the time necessary, up to three (3) months, to enter into a new contract.

<u>OPTION FOR SEPARATE COMPETITIVE BIDDING PROCEDURE:</u> The Department of General Services reserves the right to purchase supplies covered under this Contract through a separate competitive bidding procedure, whenever the department deems it to be in the best interest of the Commonwealth. The right will generally be exercised only when a specific need for a large quantity of the supply exists or the price offered is significantly lower than the Contract price.

<u>E-CATALOG:</u> The Commonwealth may require the awarded bidder(s) to supply its price list/catalog and any updated price lists/catalogs in electronic format. Price lists/catalogs must be provided in one of the following formats: Word document, Excel spreadsheet, or PDF file on 3.5-inch diskette or CD-ROM.

PROPOSAL FORMS

Bidders are cautioned to return all sheets of this invitation to your bid - bid proposal, except those specifications/bid sheets upon which no bid is submitted, otherwise, bid may be rejected.

INTENT OF CONTRACT: This contract provides for the supply or supply and installation of 100% commercial grade nylon fiber 6 or 6.6, carpet in accordance with Pennsylvania Commercial Item Description 1057 (PCID-1057), effective 03/31/2003. The PCID defines a minimum acceptable level of quality. This multiple award contract is designed to meet the needs of various customers with diverse requirements. Bidders are encouraged to provide a

range of products meeting and/or exceeding the elements of the PCID. For example, the requirement at ¶2.2 of the PCID requires static resistance of 3.5 kV, maximum. There may be applications where static resistance of 2.0 kV is desired. Carpet with 2.0 kV static resistance would clearly exceed the specification requirements contained in the PCID.

SUPPLY OF PRICE LISTS

Within 10 days after a request from a Commonwealth agency, awarded bidders must furnish the agency with a copy of the referenced price list. Any reference, which may appear on any price list, to any terms and conditions, such as F.O.B. shipping point, prices subject to change or only full case orders will be accepted, will not be part of any contract with the successful bidder(s) and will be disregarded by the Commonwealth.

INSTALLATION: The manufacturer shall certify all carpet installers. Manufacturers are required to provide training to PIBH personnel, at no charge, on the proper installation of their carpet. This training is to be provided within sixty (60) days of request. PIBH personnel must meet disability requirements as defined in PA Act 1998-57. PIBH must take all steps necessary thereafter to meet the manufacturer 's certification requirements, and a copy of the certification must be provided to the buyer of record. After certification by the selected manufacturer, PIBH must be given the first option to accept or decline installation of carpeting on a job-by-job basis. If PIBH accepts a job, you may issue a service purchase order against Legacy Contract #9980-02, SAP Current Contract, using the fair market prices from the most recently published PIBH Catalog and Price List. Agencies must contact the Director for the Bureau of Purchases, Department of General Services, to establish a fair market price for additional services not listed in the PIBH catalog and price list. Should PIBH decline a job, the agencies shall obtain a written statement to that effect from PIBH, and pursue installation from a selected installer per the terms and conditions of this contract. Bidders shall provide a list of certified carpet installers for each carpet manufacturer.

Prevailing wages must be paid for carpet installation over \$25,000

. PREVAILING MINIMUM WAGE - The contract with the awarded vendor is subject to the provisions, duties, obligations, remedies and penalties of the Pennsylvania Prevailing Wage Act, 43 P.S. Section 165-1 ET SEQ., which is incorporated herein by reference as if fully set forth herein. The contractor shall pay no less than the wage rates as determined by the Secretary of Labor and Industry (hereinafter referred to in this paragraph as "Secretary") for each craft or classification of all workmen needed to perform this contract during the term hereof for the locality in which the work is to be performed. In compliance with said Pennsylvania Prevailing Wage Act, the Prevailing Minimum Wage Predetermination, as approved by the Secretary, is attached hereto and made a part hereof.

- (A) The provisions of this paragraph shall apply to all work performed on the contract by the contractor and to all work performed on the contract by all subcontractors. The contractor shall insert in each of his subcontracts all of the stipulations contained in these required provisions and such other stipulations as may be required.
- (B) No workmen may be employed on the public work except in accordance with the classifications set forth in the decisions of the Secretary. In the event that additional or different classifications are necessary, the procedure set forth in section 7 of the regulations shall be followed.
- (C) All workmen employed or working on the public work shall be paid unconditionally, regardless of whether any contractual relationship exists or the nature of any contractor, subcontractor and workmen, not less than once a week without deduction or rebate, on any account, either directly or indirectly, except authorized deductions, the full amounts due at the time of payment, computed at the rates applicable to the time worked in the appropriate classification. Nothing in the contract, the Act or the Regulations shall prohibit the payment of more than the general prevailing minimum wage rates as determined by the Secretary to any workman or public work.

- (D) The contractor and each subcontractor shall post for the entire period of construction the wage determination decisions of the Secretary, including the effective date of any changes thereof, in a prominent and easily accessible place or places at the site of the work and at such place or places used by them to pay workmen their wages. The posted notice of wage rates must contain the following information:
 - (1) Name of project.
 - (2) Name of public body of which it is being constructed.
- (3) The crafts and classifications of workmen listed in the Secretary's general prevailing minimum wage rate determinations for the particular project.
- (4) The general prevailing minimum wage rates determined for each craft and classification and the effective date of any changes.
- (5) A statement advising workmen that if they have been paid less than the general prevailing minimum wage rate for their job classification or that the contractor and/or subcontractor are not complying with the act or the regulations in any manner whatsoever, they may file a protest with the Secretary of Labor and Industry. Any workmen paid less than the rate specified in the contract shall have a civil right of action for the difference between the wage paid and the wages stipulated in the contract, which right of action must be exercised within six (6) months from the occurrence of the event creating such right.
- (E) The contractor and all subcontractors shall keep an accurate record showing the name, craft and/or classification, number of hours worked per day, and the actual hourly rate of wage paid (including employee benefits) to each workman employed by him in connection with the public work and such record must include any deductions from each workman. The record shall be preserved for two years from the date of payment and shall be open at all reasonable hours to the inspection of the public body awarding the contract and to the Secretary or his duly authorized representatives.
- (F) Apprentices shall be limited to such numbers as shall be in accordance with a bona fide apprenticeship program registered with and approved by the Pennsylvania Apprenticeship and Training Council and only apprentices whose training and employment are in full compliance with the provisions of the Apprenticeship and Training Act approved July 14, 1961 (Act No. 304) and the Rules and Regulations issued pursuant thereto shall be employed on the public work project. Any workman using the tools of a craft who does not qualify as an apprentice within the provisions of this subsection shall be paid the rate predetermined for journeymen in that particular craft and/or classification.
- (G) Wages shall be paid without any deductions except authorized deductions. Employers not parties to a contract equiring contributions for employee benefits which the Secretary has determined to be included in the general prevailing minimum wage rate shall pay the monetary equivalent thereof directly to the workmen.
- (H) Payment of compensation to workmen for work performed on public work on a lump sum basis, or a piece work system, or a price certain for the completion of a certain amount of work, or the production of a certain result shall be deemed a violation of the Act and the Regulations, regardless of the average hourly earnings resulting therefrom.
- (I) Each contractor and each subcontractor shall file a statement each week and a final statement at the conclusion of the work on the contract with the using agency, under oath, and in form satisfactory to the Secretary, certifying that all workmen have been paid wages in strict conformity with the provisions these requirements. If any wages remain unpaid, the amount of wages due and owing to each workman respectively shall be included in the statement. A copy of the form entitled "Contractor's or Subcontractor's Weekly Payroll Certification for Public Works Projects" is attached hereto.
- (J) Before final payment is made, a final wage certification must be submitted by all contractors and subcontractors.

<u>MEASUREMENT:</u> Installer is responsible to provide the agency purchasing authority with proper amount of carpet and sundries to be purchased from this contract.

<u>SUPPLY OF SAMPLES/TECHNICAL DATA</u>: Within ten days after a request from a Commonwealth agency, awarded bidders must furnish a sample book showing representative swatches. In addition, it is the awarded contractor's responsibility to provide within ten days of request, technical data including, but not limited to, gauge, density, British spill test "E", performance rating, Vetterman drum test, post-consumer recycled content, CRI appearance retention rating scales, anti-microbial toxicity level, anti-microbial reapplication requirements, pesticide content and any other available data pertinent to making a well-informed purchasing decision.

TRADE CUSTOMS: Carpet tile shall be purchased in full-box quantities. Bidders shall supply "square yards per carton" figure for carpet tiles on their price list. Five percent (5%) over/under shipment shall be allowed for broadloom carpet, to a maximum of over/under 25 square yards. However, in all instances, contractor shall <u>not</u> deliver an under shipment when a definite quantity is needed and expressed by the ordering agency.

CLEANING AND MAINTENANCE: Bidders shall include with their price list a telephone number to contact manufacturer's customer service representative to answer questions relating to proper cleaning and maintenance procedures.

WARRANTY: The awarded vendor shall provide a one (1) year warranty on workmanship. All <u>carpet supplied</u> against this contract must have a minimum 15 year, non-prorated, written wear warranty in accordance with PCID 1057

PRODUCT CONFORMANCE The Department of General Services reserves the right to require any and all bidders to:

Provide certified data from laboratory testing performed by the bidder, or performed by an independent laboratory, as specified by the Commonwealth.

Supply published manufacturer product documentation

Permit a Commonwealth representative to witness testing at the bidders location or at an independent laboratory.

Complete a survey/questionnaire relating to the bid requirements and specifications.

Provide customer references.

Provide a product demonstration at a location near Harrisburg or the using agency location

UPDATE OPTION AND APPLICATION

The awarded vendor may update the contract price list at <u>renewal time only</u> to reflect new products, manufacturer's price increases and deletion of discontinued products, however, the percentage discount bid must remain the same.

Vendors shall submit a letter with price list to the appropriate buyer requesting review and approval of the updated price list. **The vendor shall itemize all changes in a clear concise fashion**. It is the responsibility of the vendor to adequately justify changes. All requests for updates must be accompanied by the manufacturer's latest published price list along with a letter of verification from the manufacturer. If approved, a contract change notice will be issued adding the updated price list to contract. It will then be the responsibility of the awarded vendors to distribute the price list to the

users. At no time are awarded vendors allowed to unilaterally change the products or prices on contract. Approval must be granted by the Buyer. Orders will be monitored to ensure compliance.

VENDOR NON-COMPLIANCE

Vendors found to be non-compliant with requirements of this contract may be removed as a participant upon determination of non-compliance by the Bureau of Purchases.

DELIVERIES

All articles ordered from this contract shall be delivered within a reasonable time, not to exceed ninety (90) calendar days after receipt of order, unless otherwise agreed to, in writing, by the Department of General Services.

"All deliveries against the contract shall be securely packaged so as to avoid breakage or damage in accordance with standard industry practice. All deliveries will be inside delivery to address shown on Field Purchase Order. No outside or curbside deliveries will be accepted."

MINIMUM ORDER: The minimum order under this contract shall be \$500.00 to qualify for F.O.B. Destination. Orders under \$500.00 may be delivered with additional freight cost added to invoice. Vendors shall provide ordering agencies with written quotes of additional freight charges prior to shipment.

OPTION TO RENEW

The contract(s) may be extended by mutual consent of the Commonwealth and vendor for four (4) additional one (1) year periods. If this contract is renewed for another year, a new performance bond, or a rider supplementing the original bond will be required for the extended period.

NOTE: The Department of General Services will up-date the "Authorized Dealers List" on a quarterly basis only.

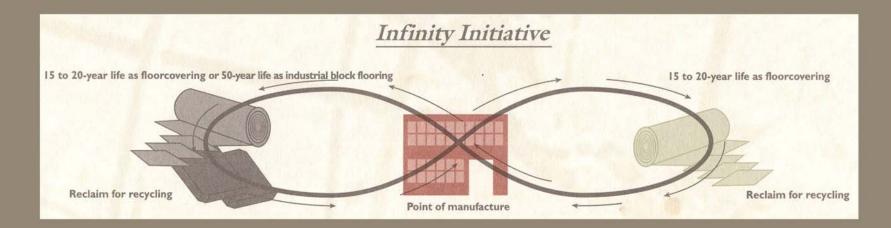
