#### TAPES, CARTRIDGES, ELECTRONIC, DATA PROCESSING

FOR: ALL USING AGENCIES OF THE COMMONWEALTH

<u>CONTRACT SCOPE/OVERVIEW:</u> This Contract No. 7440-01 (identified here and in the other documents as the "Contract") will cover the requirements of Commonwealth agencies for Tapes, Cartridges, Electronic, Data Processing.

ORDER OF PRECEDENCE: These Special Contract Terms and Conditions supplement the Standard Contract Terms and Conditions For Statewide Contracts for Supplies. To the extent that these Special Contract Terms and Conditions conflict with the Standard Contract Terms and Conditions For Statewide Contracts for Supplies, these Special Contract Terms and Conditions shall prevail.

<u>TERM OF CONTRACT</u>: This proposal covers the requirements of the Commonwealth of Pennsylvania for the Contract period beginning April 1, 2003 and ending March 31, 2004.

**TAPE REQUIREMENTS**: All tapes shall be guaranteed for five (5) years against manufacturing defects. All tapes shall be compatible with RCA, IBM, NCR, Burroughs, UNIVAC, GTE, or Honeywell Computers.

**COMPATIBILITY LIST**: Compatibility lists for tapes and cartridges shall be forwarded to agencies by awarded vendors upon request. Lists shall be furnished within ten (10) calendar days after request.

**SAMPLES**: Samples shall be made available to interested agencies upon request.

<u>AWARDS</u>: Awards shall be made only to those vendors bidding '<u>NEW & UNUSED</u>" tapes and cartridges. Refurbished tapes and cartridges are not acceptable.

**<u>DELIVERIES</u>**: All deliveries shall be **<u>FOB</u>** destination to any using agency within the Commonwealth of Pennsylvania. All articles ordered from this contract shall be delivered within a reasonable time, not to exceed thirty (30) calendar days after receipt of order, unless otherwise agreed to in writing, by the Department of General Services. All deliveries shall be securely packaged to avoid breakage or damage in accordance with standard industry practices. All deliveries will be inside delivery to the address specified on the field purchase order. No outside or curbside deliveries will be accepted.

<u>OPTION TO RENEW</u>: This contract or any part may be renewed by mutual consent of the Commonwealth and vendor(s) for additional one-year periods. Such renewals shall be limited to three (3) additional one-year periods. If this contract is renewed for another year, a new performance bond, or a rider supplementing the original bond will be required for the extended period.

<u>OPTION TO EXTEND:</u> The Department of General Services reserves the right, upon notice to the Contractor, to extend the Contract or any part of the Contract for up to three (3) months upon the same terms and conditions. This will be utilized to prevent a lapse in Contract coverage and only for the time necessary, up to three (3) months, to enter into a new contract.

PRICE ADJUSTMENT: Prices are firm for the first year of the contract. At the end of each year thereafter and beginning with the renewal period, awarded vendors may request price changes with sufficient proof from the manufacturer that the manufacturers general prices have changed. All bidders are required to submit a manufacturer's price list with the bid submission in order to establish the base price for consideration. The awarded vendor(s) must provide a copy of the manufacturer's price list in order to activate this clause at the time of renewal. Contractors that do not submit a manufacturer's price list at the renewal period will honor the original prices that were effective prior to renewal. Upon verification / acceptance by the Commonwealth, the buyer will issue a contract change notice to implement the price change(s).

MINIMUM ORDER: Minimum order place under the resultant contract shall be \$100.00.

<u>Provisions for Piggybacking Off of This Contract</u>: In addition to Commonwealth agencies, Act 57 of May 15, 1998, as amended by Act 142 of 2002, permits local public procurement units to participate in those contracts for supplies, services, or construction entered into by the Department of General Services that are made available to public procurement units. A "local public procurement unit" is defined as:

- 1) any political subdivision;
- 2) any public authority;
- 3) any tax exempt, nonprofit educational or public health institution or organization;
- 4) any nonprofit fire company, nonprofit rescue company or nonprofit ambulance company;
- 5) and to the extent provided by law, any other entity, including a council of governments or an area government that expends public funds for the procurement of supplies, services and construction.

Those local public procurement units listed above, and any other Commonwealth purchasing agencies, which issue orders under the contract are intended beneficiaries under the contract and are real parties in interest with the right to sue and be sued without joining the Commonwealth of Pennsylvania Department of General Services as a party.

Local public procurement units, and any other Commonwealth purchasing agencies, that elect to participate in the contract will order items directly from the contractor and will be responsible for payment directly to the contractor.
