

SPECIAL CONTRACT TERMS AND CONDITIONS

CONTRACT SCOPE/OVERVIEW: This contract will cover the requirements of Commonwealth agencies for aviation fuel at the Capital City Airport, New Cumberland, Pennsylvania.

ORDER OF PRECEDENCE: These Special Contract Terms and Conditions supplement the Standard Contract Terms and Conditions For Statewide Contracts for Supplies. To the extent that these Special Contract Terms and Conditions conflict with the Standard Contract Terms and Conditions For Statewide Contracts for Supplies, these Special Contract Terms and Conditions shall prevail.

TERM OF CONTRACT: The Contract shall commence upon the receipt of the awarded contract and expire on April 30, 2007.

OPTION TO EXTEND: The Department of General Services reserves the right, upon notice to the Contractor, to extend the Contract or any part of the Contract for up to three (3) months upon the same terms and conditions. This will be utilized to prevent a lapse in Contract coverage and only for the time necessary, up to three (3) months, to enter into a new contract.

OPTION FOR SEPARATE COMPETITIVE BIDDING PROCEDURE: The Department of General Services reserves the right to purchase supplies covered under this Contract through a separate competitive bidding procedure, whenever the department deems it to be in the best interest of the Commonwealth. The right will generally be exercised only when a specific need for a large quantity of the supply exists or the price offered is significantly lower than the Contract price.

SPECIFICATIONS: The selected contractor (s) is required to furnish aviation fuel in accordance with the following specifications:

- Aviation Gas, 100 Octane, Low Lead – ASTM D910, “Standard Specification for Aviation Gasoline”
- Jet A Fuel - ASTM D1655, “Standard Specification for Aviation Turbine Fuel”
- De-Icing Additive - ASTM D4171, “Standard Specification for Fuel System Icing Inhibitors”
- NFPA 407, “Standard for Aircraft Fuel Servicing”
- NFPA 30, “Flammable and Combustible Liquids Code”
- Pennsylvania Code, Title 37, Chapter 13, “Storage and Use of Flammable and Combustible Liquids”

The Commonwealth reserves the right to verify compliance with the preceding specifications.

PRICE ADJUSTMENT: Prices under the Contract will change based upon this clause only. The basis for change is the Oil Price Information Service (OPIS), Commercial Airline Jet Fuel Ranges. The applicable price will be the average contract price for Baltimore, MD.

The changes are calculated weekly and shall be effective each Tuesday.

The weekly total fuel price is thus calculated using the OPIS figure plus or minus the awarded price differential. A Change Notice to the contract is issued to incorporate the price change and changes all contract prices for deliveries on or after the effective date of the price change.

If, as a result of legislation, rule-making, rate-making, or any related act of a legislative or regulatory body subsequent to bid opening, the Contractor’s cost of supplying aviation fuel increases, the Contractor may request a change in price by furnishing the Director, Commodity Management, within the Bureau of Procurement, with sufficient documentation showing the direct effect on the Contractor’s cost. Price adjustments for the aforementioned reasons will not occur more than once a month after the opening date.
